

THE TRUST IS A DIRECT MANAGER AND ADMINISTRATOR FOR PROJECTS AND ORGANIZATIONS WORKING IN THE FINE AND PERFORMING ARTS, HERITAGE, HUMANITIES, JOURNALISM, DESIGN AND CREATIVE PRACTICES.
